



## 2020 WAIVER & PHOTO PERMISSION – Children’s Yoga

*On behalf of my minor child, I hereby authorize my child to participate in People for Palmer Park’s outdoor yoga classes between August 8 and August 29, 2020 taught by a certified yoga instructor. I am providing my permission for my minor child to participate in this activity, and agree to the following:*

1. Acknowledge, agree and represent that I understand the nature of the activity stated above and that my minor child is in good health and proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted in an open public space and upon which hazards are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe I will immediately discontinue my child’s further participation in the activity.
2. Fully understand that: (a) activities may involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death (“risks”); (b) these risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the activity, and I fully accept and assume all such risks and responsibility for losses, costs and damages incurred as a result of my child’s participation in the activity.
3. Will notify the instructor about any health issues or challenges in advance of instruction.
4. **Given the COVID-19 pandemic, participants in children’s yoga will be encouraged to wear a face mask and to social distance. PFPP will provide masks to any participant who needs one and hand sanitizer will be made available. Participants will need to bring their own mat/blanket/towel as they will not be provided during this time.**
5. Hereby release from any and all liability the People for Palmer Park (PFPP), its volunteers, the instructors, and the City of Detroit from any and all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the activity or rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement I, or anyone on my behalf, makes a claim against PFPP or the City, I will indemnify, save and hold harmless each party from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
6. Hereby grant full permission to PFPP to be responsible and tasteful in the use of my photograph or my child’s photograph in publications or promotional materials (printed or electronic) supporting this program. This consent also serves to waive all rights of privacy or compensation, which I may have in connection with the use of my photograph and/or name or my child’s photograph and/or name.

*I have read the agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance. I understand it to be a complete and unconditional release of all liability allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.*
